It should be noted that all above figures relating to recommendations, withdrawals etc., refer to the year in which the application was lodged and NOT to the year in which the recommendation, withdrawal etc. was made. These statistics reflect activity since the implementation of the Refugee Act 1996 (as amended) on 17/11/2000

* Two 1997 cases which cannot yet be finalised are included in the 1998 figure and an additional two have been added to the 1998 recommendations. All other pre 1998 cases have been processed.

Processing of Outstanding Applications

All adult applicants are scheduled for interviews. In July 1473 interviews were scheduled and applicants attended in 508 cases (attendance rate of 34%)

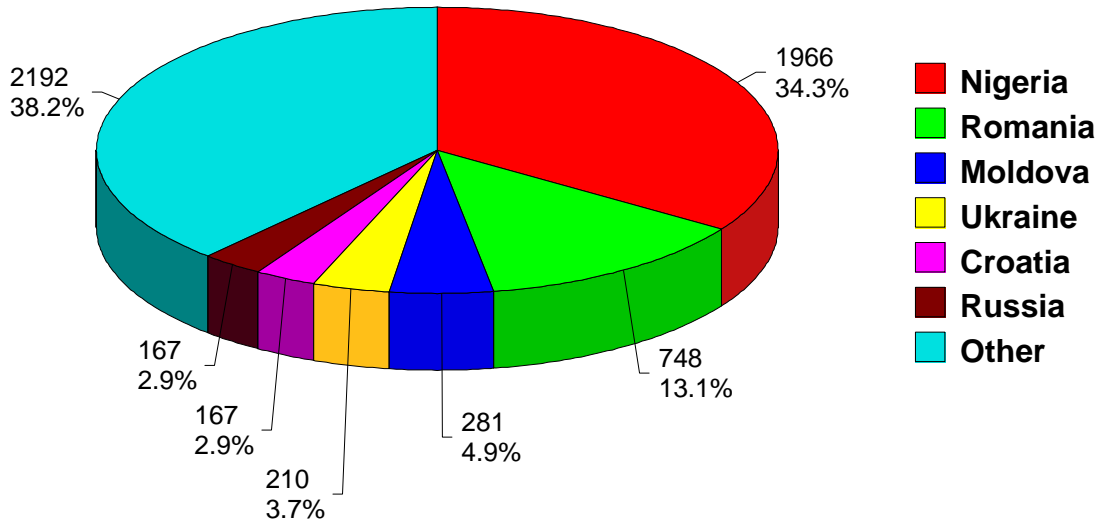
It should be noted that these recommendations refer to the year in which the recommendations were made and NOT to the year in which the applications were lodged.
